# FIREARM/PINK SLIP LEGISLATION

“DO SOMETHING”

- Aug. 4 – Mass shooting in Dayton
- Aug. 6 - Governor outlines 17-point action plan
- Oct. 15 - SB 221 STRONG OHIO bill introduced



# SURPRISE BILLING

- Language included in the budget bill and vetoed by the Governor; executive order expressed commitment to continue working on the issue
- S.B. 198 (S. Huffman) introduced on Sept. 16
- H.B. 388 (A. Holmes) introduced on Nov. 5
- **Key issues: Protecting the patient, benchmark reimbursement rate, role of arbitration**



# PRICE TRANSPARENCY

- Unworkable language included in the budget bill and vetoed by the Governor; executive order expressed commitment to continue working on the issue
- S.B. 97 (S. Huffman) was amended to reflect OHA-supported budget language
  - Beginning Jan. 2021, generally requires a hospital to provide a patient, **upon request**, with a cost estimate for each health care service scheduled at least seven days in advance.
- Passed by the Senate on Oct. 9; hearings ongoing in the House
