In addition, she co- leads the S&P Global Ratings' public finance team that develops best practices for analyzing issuers' pension liabilities and post-employment benefit obligations. Anne publishes articles on these topics to advance market participants' understanding of the pension and OPEB analysis.

Prior to joining S&P Global, Anne was a State Analyst at Moody's Investors Service, and was the primary analyst on high profile states, including Connecticut and

Kentucky. Before joining Moody's, Anne held positions of increasing responsibility at Lehman Brothers and Barclays Capital. In those positions, she managed portfolios exceeding \$7 billion and actively assessed significant issuers across the healthcare, higher education, local government and public power sectors, including the Commonwealth of Puerto Rico, the City of Detroit, OSF Healthcare, Trinity Health, Scripps Health, Partners HealthCare, and Mercy Health. At Lehman Brothers and Barclays Capital, Anne approved issuers for various capital market products, including private placements, standby letters of credit, letters of credit, interest rate swaps and other traded products.

Anne began her career at S&P as a credit analyst and covered various sectors, including health insurance providers. Anne has an MBA in Finance and Accounting from NYU's Stern School of Business and a BA from the University College Cork, Ireland.
