


Best and Worst Cities for an Active Lifestyle

Based on WalletHub's Active Lifestyle Score as of Jan 2025




Happiest States in America


Life Expectancy across 50 States, ranked highest to lowest

Based on CDC National Vital Statistics Report as of August 21, 2024




Healthiest States for Women and Children in 2024

Based on American's Health Rankings 2024 Health of Women and Children Report




Fiscal Policy Score by State Governor

Best and Worst States for Healthcare Access



Policy

Wildfire EPs

- Hawaii's wildfire Public Health Emergency declared August 11, 2023
- HAH worked with AG and Governor on EPs
- Series of waivers, including:
 - Requirement of state license for out-of-state MDs, LPN,s RNs, APRNs, and mental health providers to practice in Hawaii
 - Requirement that controlled substances prescription originates in state
 - Requirement of in-person consultation prior to telehealth consultations
- 20th Wildfire EP signed Feb 4
 - All essential health-related waivers rolled over into 20^{th EP}
 - EPs in effect for max. of 60 days by state law
 - 20th EP in effect through Apr 5, 2025
- Working with AG and Governor on 21st Wildfire EP



Population Trends


US Population 70+ yrs

Hawaii Population 70+ yrs





Projection of Ratio of 18-64 Year Olds to 70+ Year Olds in Hawaii from 2020-2050





Healthcare Workforce Shortage Solutions

- Reduce need for healthcare workers Improve population health
- Import workers from other nations dependent on federal immigration policies
- Shift higher proportion of workers to direct patient care offshore back-office functions
- Remote/virtual monitoring
- Automate tasks
- Increase use of Al
- Attract more workers to Hawaii i.e., loan repayment
- Attract greater proportion of local work force



Hawaii Healthcare Education and Loan Repayment Program (HELP)

- Funding Priorities
 - Primary care, all islands
 - Behavioral health providers, all islands
 - Rural providers (any eligible specialty)
- Funds Available for FY 2024 and FY 2025 \$37M
 - \$30M of state funds
 - \$5M from Benioff Foundation for Hawaii Island
 - \$2M of federal funds for existing federal program
 - Less operational and program administration costs
- Work Commitment
 - Two years regardless of funding level



Hawaii Healthcare Education and Loan Repayment Program (HELP)

- Applications to Date
 - 2,600 received
 - 300 do not meet criteria or have withdrawn application
 - 2,300 qualify
- Awarded for FY 2024 and FY 2025
 - Oahu 52.2% (465 applicants)
 - Kauai 5.1% (45 applicants)
 - Maui 15.1% (135 applicants)
 - Hawaii Island 26.5% (236 applicants higher number due to combination of state and Benioff funds)
 - Mainland residency 1.1% (10 applicants)
- All Funds for FY2024 and FY 2025 Committed

Healthcare Workforce Initiative

Hawaii healthcare employers, educators, workforce development and regulatory organizations collaborating to better match supply with demand.

2019 Workforce Demand Report

- 2,200 open positions
- 76 patient facing professions
- 10% vacancy rate

2022 Workforce Demand Report

- 3,873 open positions (76% increase over 2019)
- 89 patient facing professions
- 17% vacancy rate

2024 Workforce Demand Report

- 4,669 open positions (21% increase over 2022)
- 94 professions (Now includes food services and environmental services/housekeeping
- 14% vacancy rate

OUR VISION

Establish a best-in-the-nation, state-wide network of health learning labs at public high schools in Hawai'i

Hawaii's public high schools are a primary source for the future healthcare workforce

- Approximately 50% of graduates from Hawaii public high schools go on to higher education
- A portion of this 50% enter pre-med, nursing, social work, and other healthcare-related professions
- Approximately 50% of graduates from Hawaii public high schools do not go on to further education
- This 50% is a primary source of entry-level workers in healthcare
- Healthcare needs a higher proportion of each 50% to meet workforce needs

How do we attract a higher proportion of public high school students?

- Increase awareness of broad range of healthcare careers in middle schools
- Demonstrate wide range of career trajectory options regardless of entry point
- Develop glidepaths for entry level professions
- Create environment that inspires students
- Create environment that excites parents
- Create environment that motivates teachers
- Build best in nation, statewide network of public high school health learning labs










Funding

- Funding for the first school Wai'anae High School
 - Proof of Concept
 - 2 classrooms
- Estimated cost for Wai'anae \$3.2M
 - Funds raised from state and local organizations
- Projected completion December 2025
- 30 schools eligible across state
- Approximately \$100M
 - Seeking funding from major philanthropic organizations
